AFFIDAVIT OF MRS. R. NIRANJANI

I, Mrs.R. Niranjani aged 61 years, Authorized Signatory and Correspondent of the Vidyodaya Schools situated at No 1, Thirumalai Road, T. Nagar, Chennai – 600 017, do hereby solemnly affirm and state as follows:

1. I state that the educational agency, Vidyodaya Schools Society proposes to switch the course of school from the Matriculation to the Central Board of Secondary Education (CBSE) course. On this switch, the Matriculation course will be closed and the school will continue under the CBSE course. It will be called as "Vidyodaya Academy".

2. I state that the intimation regarding the switching of the school's affiliation from the Matriculation Board to the Central Board of Secondary Education (CBSE) has been communicated to the parents of all the pupils studying in the school.
3. I hereby state that the switching over from Matriculation to CBSE will be from PRE-KG to standard VII from this phase and hereafter every year each class from VIII th to XII th will be migrated.
4. I state that at the end of the current academic year, there will be no disruption in continuance of the study of the pupils currently studying in our school, i.e. Vidyodaya Matriculation Hr. Sec. Academy
5. I state that all students, including those admitted under the Right of Children to Free and Compulsory Education (RTE) Act, shall be given the option to continue their education either in Vidyodaya Matriculation Higher Secondary Academy (proposed to be transitioned to CBSE) or in Vidyodaya Girls' Higher Secondary School, an aided school offering the Samacheer Kalvi curriculum, both of which are situated within the same campus and administered by the same Trust.

The Management hereby undertakes to bear the tuition fees of all RTE students, irrespective of whether they continue in Vidyodaya Matriculation Higher Secondary Academy (CBSE) or opt to join Vidyodaya Girls' Higher Secondary School, until the completion of Class VIII.

6. In case of any existing students (including RTE) opts out of CBSE board, such students will be accommodated in our own Govt.

7. I state that the pupils will continue to remain enrolled in the same school and as such issue of admission of the pupils to another recognized school before closure does not arise.
8. I state that since the school will be a continuing entity there arises no need to hand over permanent records of the school. Nevertheless, if copies of any school records need to be submitted to the concerned competent authority, It shall be done immediately.
9. I state that there will be no retrenchment of staff and therefore no question of deployment of retrenched staff will arise.
10. All the members of Vidyodaya Matriculation Hr. Sec. Academy have given their consent for the switching of the school's affiliation from the Matriculation Board to the Central Board of Secondary Education(CBSE) Board.

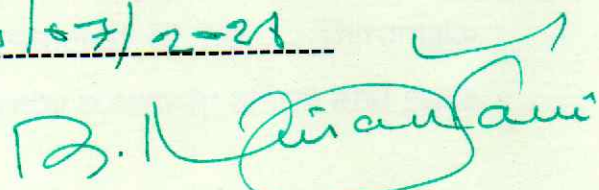
